Terms of the Crescent Township Snow Angel Program

This Snow Angels Program Application Agreement (this "Agreement") is created and effective as of the date of the APPLICANT's signature on this Agreement.

WHEREAS, the Snow Angels Program is the Township of Crescent (the "TOWNSHIP") snow and ice removal service for older neighbors, veteran neighbors, and neighbors with disabilities, who do not have the means to remove their own snow and ice (the "Service")

WHEREAS, APPLICANT has applied to the TOWNSHIP for participation in the Snow Angels Program as a volunteer to provide the Service;

NOW THEREFORE, the undersigned APPLICANT hereby acknowledges and agrees as follows:

## I. SNOW ANGELS' REQUIREMENTS AND RULES

\_\_\_ APPLICANT certifies that APPLICANT is capable of removing snow and ice from a property.

\_\_\_ APPLICANT understands that the only service provided will be snow and ice removal.

\_\_\_ APPLICANT understands that the APPLICANT'S participation in the Snow Angels Program shall not include any interactions or communications with the recipient of the Service except to the extent necessary to perform the Service.

\_\_\_ APPLICANT also understands that the Service requires no entry inside the residence of the recipient of the Service, and APPLICANT shall not enter the inside of the residence of the recipient of the Service for any reason.

\_\_\_ APPLICANT agrees to treat any and all Snow Angels recipients with dignity and respect, or risk expulsion from the Snow Angels Program at the complete discretion of the TOWNSHIP.

II. RELEASE & HOLD HARMLESS

\_\_\_\_APPLICANT agrees to assume all risk of injury, harm, or damage to APPLICANT's person or property which may arise as a result of the performance of the Service and does hereby release and agree to indemnify and hold harmless the TOWNSHIP, its agents, officers, and employees from any and all liability actions, damages, and claims of any kind and nature whatsoever for injury or harm that might arise in connection with participation in this Service.

\_\_\_\_APPLICANT further agrees that this Section II of this Agreement is intended to be as broad and inclusive as is permitted by the law of the Commonwealth of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

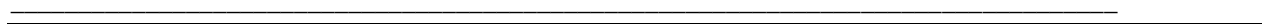

After you have been paired with a neighbor(s) in need, you are responsible for providing a shovel and salt or working out with your recipient if they have a shovel/salt at their home.

We will contact you via email with confirmation details when you have been assigned a neighbor. You may not be assigned to help a neighbor immediately. Neighbors request help throughout the winter season. You may be assigned immediately, a few weeks after you sign up, or later during the winter.

Your assignment depends on if a neighbor near you needs help. If none of your neighbors sign up, we may not be able to assign you. Either way, we will keep in touch!

Groups of volunteers are encouraged to work together. Gather friends, family clubs, church groups, employee groups or individuals to provide community service while meeting new neighbors.  
Volunteers must be 15 years older OR be accompanied by a parents/guardian.  
Commit to taking at least one property, or more, as time permits.  
All properties will be located in Crescent Township.  
Volunteers are required to complete the application which includes a liability waiver and photography use agreement. All participants must complete, sign, and submit the form before a volunteer match can be made.
